

# DANCE GUIDELINES

All students and parents are advised of the following guidelines concerning our school dances.

- 1 Tickets will be sold one week prior to the dance before school only. Tickets may only be purchased with this permission slip. **NO TICKETS WILL BE SOLD AFTER 7:40 A.M. OR AT THE DOOR.**
- 2 Dances are open only to students presently attending Scott. The ONLY EXCEPTIONS are specially announced dances where guests will be allowed. An example would be our 8<sup>th</sup> grade semi-formal dance.
- 3 All students should be picked up or leave school grounds promptly. A few students linger long after the dances are over. Please leave school property within 15 minutes after the dance is over. Supervision ends at 9:00 p.m.
- 4 We're asking that all students remain in our cafeteria until the DANCE IS OVER. If by chance a student should need or desire to leave early, a parent must meet them at the door. A chaperone should be told if a student is leaving early. Parents must meet their child at the door to escort them to their car.
- 5 No student may participate in an evening or extra-curricular activity if they did not attend school that day. This is a district policy. Special circumstances will be dealt with by school administration on a case by case basis **PRIOR TO THE DANCE.**
- 6 Our discipline code and school policies (including eligibility and obligation) are in effect at our school dances.
- 7 Students on suspension (including ISS) may not attend our dances until suspension time has been served.
- 8 Once received, all students MUST present current ID cards at the door. NO student will be admitted into the dance without an ID. NO EXCEPTIONS.
- 9 No transfer of tickets from one student to another.
- 10 No refunds or exchanges of tickets or fee.
- 11 Please tell your child where you can be reached in case of emergency or necessity. Give them specifics with telephone number.
- 12 FAILURE TO MEET THE ABOVE GUIDELINES MAY RESULT IN YOUR DANCE PRIVILEGES BEING TAKEN AWAY.**
- 13 Instruct your son/daughter concerning dismissal procedures below. Advise your child they are accountable to follow your directions specifically. Review procedures below.
