- 1. Sharon Ross wants to see the District's savings, in the budget, resulting from outsourcing. She also wants to see the costs to be charged by Servicemaster. She feels the custodians are being punished for the lack of poor management by the prior administration.
- 2. Cass Rowland (*CASD Maintenance Staff for 20 years*) questioned the \$1.2/million savings the District expects to save through outsourcing the custodial/maintenance staff and job cuts. He asked if the costs associated with snow removal, lining of the baseball fields, and set-up/turn-down of the basketball courts, etc. are all included in the savings. Mr. Rowland reminded the Board that those who are threatened with losing their jobs to outsourcing have homes, families and some with children in college, and he asked them to consider giving advanced notice, should their jobs be eliminated, in order to search for other employment.
