D Tax Collector Agreement

Tax Collector Compensation Selection

This Agreement is made this 1st day of January, 2018, by and between <u>BARRY 5</u>, <u>BEACH</u> with an address of <u>I6 GRANGER LANE</u>, <u>COATESVILLE</u>, PA <u>19320</u>, the duly elected Tax Collector for <u>CACN TOWNSHIP</u> (hereafter referred to as Tax Collector),

- and -

the Coatesville Area School District, a political subdivision with an address of 3030 C.G. Zinn Road, Thorndale, PA 19372 (hereafter referred to as District),

By resolution, the Coatesville Area School District Board of School Directors approved the following compensation options for the collection of school real estate taxes on January 26, 2016. The Tax Collector must choose one option no later than April 1, 2018, for the length of his/her term of office. If the Tax Collector does not choose any option, then the Tax Collector will have the full responsibility as created by law for tax collection duties, at the District's established rate of \$1.35 cents per collected bill. Tax Collector will indicate their selection by placing their initials beside one option below.

- ____Option 1: Tax Collector places tax bills in envelopes (bills with like addresses will be consolidated into one envelope), mails, collects, and deposits the taxes and performs data entry at the School District Business Office or provides an electronic file approved by the School District for downloading into the District's tax files. Compensation for this option will be \$1.35 cents per collected bill.
 - 1. Tax Collector must make daily deposits of all taxes collected and cleared for the School District in a bank account designated by the School District.
 - 2. Tax Collector shall remit collected taxes to the Board Treasurer along with an electronic (data file) report detailing the sources of said revenues:

weekly during the months of July, August, and September,

bi-weekly during the months of October and thereafter during the remainder of the current tax year.

All receipts shall be supported by the Tax Collector's tax reconciliation report.

- 3. Immediately upon receipt of payment, Tax Collector shall stamp the receipt of the taxpayer and the receipt for the School District with the date on which the tax was paid to the Tax Collector.
- Tax Collector shall comply with all reasonable requirements, procedures, policies, and resolutions adopted now or in the future by the School District for the collection of school taxes.
- 5. Tax Collector will be paid by the School District upon completion of the Tax Collector's responsibilities.
- 6. School District will provide tax bills, duplicates, postage, and envelopes to the Tax Collector.

- 7. Tax Collector shall comply with regulations for continuing education. At the time of this resolution, regulations require the Tax Collector to obtain ten hours of continuing education during each year. Costs associated with the continuing education program will be the responsibility of the Tax Collector.
- 8. Tax Collector shall submit the final reconciled report of taxes collected and outstanding annually by January 15th.
- X Option 2: Tax Collector deputizes the District to collect the taxes. Tax Collector will not have any responsibilities and will receive \$.50 per bill as compensation. The Tax Collector acknowledges that he/she shall not appoint any other deputy tax collector without the express written consent of the District. Further, Tax Collector acknowledges that the District shall have the right to assign any or all of its rights and/or obligations pursuant to this agreement.

The Tax Collector shall enter into a written agreement with the District acknowledging which of the two options the Tax Collector chooses. Should the Tax Collector refuse to execute this agreement it will be agreed that the Tax Collector shall fulfill the responsibilities as stated within Option 1.

This agreement shall be in effect through December 31, 2021.
