

Last year, the Coatesville girls won a \$200 prize for submitting the winning video in our "What Girls Star Means To Me" contest!

In addition to the training and manuals, we paid a \$500 annual stipend to each facilitator and gave approximately \$10 per girl as snack money. We did not want the district to incur any costs, however an activity bus has been graciously provided for one way transportation of the middle school girls to the 9/10 Center.

In May 2017, the Girls Star Board of Directors voted to cease operations. Many of the directors had served on the Board since its inception and new directors were very difficult to find. Thus the painful decision had to be made to dissolve Girls Star Inc. Our account had enough funds to support our sites for two more years. We decided to divide the remaining funds in our account among our sites, so two facilitators at each school could still receive their \$500 annual stipend, a \$250 annual stipend would be paid to the Coatesville teacher willing to organize the 5 schools (Camille has been doing this job) plus money for the all important snacks. Dr. Taschner agreed to accept this money that would be used solely to support the Girls Star program. We have a check to present for \$12,227.85. At this point, I do not know to whom the check should be written.


